





### Federico de MONTALVO, Professor, Universidad Pontificia Comillas ICAI-ICADE, Madrid

Federico de Montalvo Jääskeläinen holds a PhD in Constitutional Law. He is an Assistant Professor of Constitutional Law; teaching both Constitutional Law and Health Law. He also has spent time in private practice and started to practice as a Lawyer and work as a Professor of Constitutional Law at the same time.

As a lawyer, he specialized in Administrative and Constitutional Law and Medical, Pharmaceutical and Biomedical Law. He founded his own law firm (www.asjusa.com) in 1998 which he left in 2011, having been its President for 13 years.

As a Professor specialized in Constitutional Law and Comparative Constitutional Law, he teaches on political organization and Institutions of the Constitutional State as well as human rights and civil liberties. His areas of research are Medical and Biomedical Law and Public Health Law.

He has recently taught and given lectures in De Paul University, Brooklyn Law School, Fordham University, University of York, Universidad Diego Portales, Universidad Rey Juan Carlos. He has taught Comparative Constitutional Law for fifteen years, focusing the subject mainly on the US Constitutional system Currently he holds the Vice Chair of the Spanish Commission for Bioethical Issues (Comité de Bioética de España) (2012-) (www.comitedebioetica.es ) and is member of the International Bioethics Committee (IBC) of UNESCO (2014-on-going).



#### Francisco PEREIRA COUTINHO, Professor, Universidade Nova de Lisboa

Francisco Pereira Coutinho has a law degree and a PhD in law from Universidade Nova de Lisboa Law School. He currently teaches constitutional law, internacional law and European law in Universidade Autónoma de Lisboa and Faculdade de Ciências Sociais e Humanas da Universidade Nova de Lisboa.

He is also a legal advisor in the Portuguese Diplomatic Academy (Instituto Diplomático).



#### Paulo RANGEL MEP, Vice-Chairman of the EPP party, Vice-Chairman of the EPP Group in the European Parliament, EIN Chairman

Member of the European Parliament and Vice Chairmen of the EPP Group since 2009. Vice Chairman of the EPP Group responsible for the European Ideas Network. EPP Vice Chairmen since 2015. Chairman of the EU Brazil Parliamentary Delegation in the European Parliament and Vice Chairman of the Constitutional Affairs Committee in the European Parliament since 2014. Head of the PSD Portuguese delegation and Administrator of the Robert Schuman Foundation since 2009. Chairman of

the PSD parliamentary group in 2008-2009 and member of the Portuguese Parliament (Assembly of the Republic) during the 10th legislature. Deputy Secretary of State in the Ministry of Justice under the 16th constitutional government. Graduate of the Faculty of Law, Portuguese Catholic University of Porto. Master's in Juridical-Political Sciences, Law Faculty of the University of Coimbra (in progress), and Doctorate in Public Law, Law Faculty of the Universidade Nova of Lisbon (in progress). Member of the Cuatrecasas Gonçalves Pereira Legal Partnership. Speciality: Public Law. Lecturer in the Law Faculty of the Portuguese Catholic University. In charge of Political Sciences and responsible for leading the Cuatrecases Seminars on Public Procurement and Precautionary Measures in Administration Law. Lecturer of the MBA in the Porto Business School. Member of the board of directors of the Porto Trade Association, chairmen of the General Assembly of RAR Group and regular commentator in various branches of the media ("Conselho Superior" RDP Antena 1 on Mondays, "Palavra e Poder" in newspaper Público on Tuesdays, "Prova dos Nove" in TVI24 on Thursdays). Publications: many speeches and lectures, scholarly articles and books on legal, political and constitutional issues, including Repensar o Poder Judical, Publicações Universidade Católica, 2001, O Estado do Estado, D. Quixote, 2009. Research work: with the DAAD in Frankfurt, with the European Institute in Florence, the University of Osnabrück, the University of Upsala, the University of Lausanne, the University of Bologna, the University of Genoa and the University of Freiburg. Awarded the Grosse Verdienstkreuz mit Stern by the Federal Republic of German (2009); the Council of Europe's René Cassin Prize (1989); the D. António Ferreira Gomes Prize (1986).



#### Roberta RIBEIRO OERTEL, Lecturer at EIPA Luxembourg, European Centre for Judges and Lawyers

Roberta Ribeiro Oertel is a Lecturer at EIPA Luxembourg – European Centre for Judges and Lawyers. She studied Law at the Pontificia Universidade Catolica de Sao Paulo, Brazil (1996-2000). She went on to obtain a Master in International Law (2003) from the University of Strasbourg, France. In 2013 Roberta also submitted a PhD at the Faculty of Law in Strasbourg.

Roberta has worked for the Ecole régional des Avocats du Grand-Est in Strasbourg (2006-2010), where she was Director of legal training for lawyers responsible for

developing and preparing training. Since then, she has been teaching regularly at the Ecole des Avocats de Paris (EFB) in a number of projects related to European law in the field of civil and commercial matters. Before joining EIPA, Roberta worked as a lawyer in Strasbourg (2007-2010) and Brazil for several years (2001-2013). She also represented interests of private companies in Brussels in the field of competition law, arbitration, mediation and international trading (2004-2005).



#### André SAPIR, Senior Fellow, Bruegel, University Professor at the Université libre de Bruxelles (ULB)

André Sapir, a Belgian citizen, is Senior Fellow at Bruegel. He is also University Professor at the Université libre de Bruxelles (ULB) and Research Fellow of the London-based Centre for Economic Policy Research.

Between 1990 and 2004, he worked for the European Commission, first as Economic Advisor to the Director-General for Economic and Financial Affairs, and then as Principal Economic Advisor to President Prodi, also heading his Economic Advisory

Group. In 2004, he published 'An Agenda for a Growing Europe', a report to the president of the Commission by a group of independent experts that is known as the Sapir report. After leaving the Commission, he first served as External Member of President Barroso's Economic Advisory Group and then as Member of the General Board (and Chair of the Advisory Scientific Committee) of the European Systemic Risk Board based at the European Central Bank in Frankfurt.

André has written extensively on European integration, international trade, and globalisation. He holds a PhD in economics from the Johns Hopkins University in Baltimore, where he worked under the supervision of Béla Balassa. He was elected Member of the Academia Europaea and of the Royal Academy of Belgium for Science and the Arts.




#### Wolfgang WESSELS, Professor, Jean Monnet Chair, Department of Political Science and European Studies, University of Cologne

Prof. Dr. Wolfgang Wessels, born in 1948, studied Economics and Political Science at the University of Cologne and in the USA. Since 1981 he is Visiting Professor at the College of Europe, Bruges and Natolin. He was Director of the Institut für Europäische Politik in Bonn (1973-1993) and Head of the Department of Political and Administrative Studies at the College of Europe in Bruges (1980-1996). 1994 to 2016 he held a Jean-Monnet-Chair at the University of Cologne. Since 2016 he is

Director of the Centre for Turkey and European Union Studies (CETEUS) at the University of Cologne. He held the Chaire Européenne at Sciences Po Paris (1999) and was Jean Monnet Visiting Professor at the Robert Schuman Center for Advanced Studies at the European University Institute in Florence (2000). He was also a member of the high level group of the European Commission for the reform of the CFSP and for the revision of the Treaty of Maastricht (1995-1997). Moreover, he is the Chairperson of the Executive Board of the Institut für Europäische Politik (IEP, Berlin) and was Chairperson of the Executive Board of the Trans European Policy Studies Association (TEPSA, Brussels) until 2016. Since 2010 he is Vice-President of the German consortium for the foundation of the Turkish-German University, Istanbul. He is involved in several research and teaching networks such as THESEUS, PADEMIA and FEUTURE.

In 2007 he was awarded the Jean Monnet medal in gold for lifelong learning. In 2011 he was awarded an Ad personam Jean Monnet Chair and the UACES Award for Lifetime Achievement in Contemporary European Studies. In 2015 he was awarded with the "Universitätspreis Forschung" by the University of Cologne for his excellence in research and in 2016 with the Vision for Europe Award of the Prague European Summit. Prof. Wessels is co-editor of the "Jahrbuch der Europäischen Union" (35th Edition) and the "Europa von A-Z, Taschenbuch der europäischen Integration" (14th Edition) and has published widely in leading Journals and edited volumes. Prof. Wessels has published a book on the European Council with Palgrave in 2016.
